(15) Special fees for police guarding of aircrafts	
For every policeman guard for the time period of one hour or part of it	22.38
(16) Special fees for fire brigade services	
For every fire engine for every hour or part of it	50.13

AMENDEMENTS

1. Amendments from previous list of charges that was applicable as from 1st March 2011, relate to:
 - a) The indexation of the Additional Regulated Airport Charges.
 - b) Pre-Conditioned Air charges have now been included.

Notes

1. The indexation of Additional Regulated Airport Charges is applicable every 1st of May every year. The Additional Regulated Airport Charges are CUTE Fee, BRS Fee, Fire Service Recovery Fee, Security Fee, Fuel Throughput Fee, Air Bridge Rental Charge and Power Supply Fee.
2. The indexation of Existing Regulated Airport Charges is applicable every 1st of May every two years (last indexation: 1st May 2010). The Existing Regulated Airport Charges include the remaining major charges such as Passenger Fees and Landing Fees.
